

# NGC UK Services & Fees

Effective July 1, 2018

For submissions to NGC International UK Ltd. (NGC UK) only.

US, world and ancient coins must be submitted on separate submission forms.

All fees are in pounds and include VAT.

Fees include round trip shipping and insurance between the NGC UK and NGC Headquarters.

A £12 handling fee per submission form applies to all submissions.



NGC is the official grading service of the ANA and PNG.

NGC GRADING TIERS	FEE PER COIN (GBP)	REQUIREMENTS (Maximum values are per coin)
Unlimited Value WalkThrough	£475	All coins. Unlimited value. Includes Scratch-Resistant Holder.
WalkThrough	£260	All coins. Maximum value £75,000. Includes Scratch-Resistant Holder.
Express	£70	All coins. Maximum value £7,500. Includes Scratch-Resistant Holder.
† All tiers above include Scratch-Resistant Holders for no additional fee. † † Upgrade to Scratch-Resistant Holders for the following tiers for an additional £4 per coin. †		
Standard	£40	All coins. Maximum value £2,500.
Gold	£30	All common date gold coins. Maximum value £2,500. No ancient coins.
Value	£21	All non-gold coins. Maximum value £250. Ancient coins submitted under the Value tier receive a basic description/grade only.
Modern	£18	All coins 1955 to present (no patterns, die trials, etc.). Maximum value £1,500.
Mixed Modern Bulk	£17	All coins 1955 to present (no patterns, die trials, etc.). Coins may be different types. Maximum value £1,500. <b>One hundred (100)-coin minimum.</b> Special Label/Releases is included with the Modern Bulk grading fee.
Modern Bulk	£15	All coins 1955 to present (no patterns, die trials, etc.). Coins must be same type. Maximum value £1,500. <b>One hundred (100)-coin minimum.</b> Special Label/Releases is included with the Modern Bulk grading fee.

Turnaround times are approximate and are not guaranteed. Occasionally there may be a delay on world coins as extra research is required on more esoteric items.

Early Releases / First Releases	Tier fee + £8	Use this service to receive either the EARLY RELEASES or FIRST RELEASES designation for qualifying coins. Select only one. Visit <a href="http://NGCcoin.uk/cutoffdates">NGCcoin.uk/cutoffdates</a> for a list of eligible coins and submission cutoff dates.
Special Label	Tier fee + £4	Use this service to request a special NGC label. For a list of special NGC labels, visit <a href="http://NGCcoin.uk/labels">NGCcoin.uk/labels</a> . <b>Note:</b> If you would like to have different special labels for the coins listed on the form, write "MIXED" on the Special Label line in Section 13 and list the desired Special Label Name and # on each line next to the coin in Section 17.
VarietyPlus	Tier fee + £14	Upon request, NGC examines coins for recognized varieties and certifies with applicable designation. Choose a grading tier according to coin value. See <a href="http://NGCcoin.uk/varietyplus">NGCcoin.uk/varietyplus</a> for a complete list of varieties we recognize. If you would like a coin already graded by NGC reviewed for variety, do not select a grading tier. Select VarietyPlus service option. The VarietyPlus fee applies when requested regardless of whether NGC determines the coin to be a recognized variety.
Mint Error	Tier fee + £14	NGC examines Mint Errors and assigns a designation. Coins will be encapsulated at NGC's discretion. Also, choose a grading tier according to coin value and desired turnaround. The Mint Error fee applies when requested regardless of whether NGC determines the coin to be a recognized mint error.
NGC Oversize Holder	Tier fee + £18	Coins over 45 mm in diameter are placed in an NGC Oversize Holder. Must be submitted on a separate submission form.
Double Thick Holder	Tier fee + £4	Coins 4.5 to 9 mm thick (and with a diameter of 45 mm or less) are placed in a Double Thick Holder. Must be submitted on a separate submission form.
ReGrade	Tier fee	If you disagree with a grade assigned by NGC, you may submit the coin for review for a higher grade. Coin must be intact in its holder. Also choose a grading tier according to coin value.
CrossOver	Tier fee	Review of PCGS-holdered coins for NGC certification. Coins will be removed from their holders and encapsulated by NGC only if NGC determines that the coins will receive an NGC grade that is the same grade or higher than the grade assigned by PCGS. If you would like your PCGS-holdered coin certified by NGC even if NGC determines that it will receive a lower numeric grade, specify ANY in the CrossOver Minimum Grade column of the NGC Submission Form. If you would like your PCGS-holdered coin certified by NGC even if NGC determines that it will receive an NGC Details grade (or a lower numeric grade), specify DETAILS in the CrossOver Minimum Grade column of the NGC Submission Form. You may not request a minimum grade that is higher than the grade that is on the PCGS holder. Coins holdered by other grading services are not eligible for CrossOver and must be removed from their holders and submitted raw (not holdered), or they may be submitted in their holders if they are accompanied by NGC's Consent to Remove Coin(s) from Holder(s) Form.

REHOLDERS	FEE PER COIN (GBP)	DESCRIPTION
ReHolder	£12	A coin in an NGC holder can be submitted for placement in a new holder. Maximum value £7,500. <b>Note:</b> Submit Double Thick Holders for ReHolder under either ReHolder or High Value ReHolder, as applicable.
High Value ReHolder	£22	A coin in an NGC holder is placed in a new holder. Unlimited value.
Oversize ReHolder	£18	A coin in an NGC Oversize Holder (coins over 45 mm) is placed in a new holder. Maximum value £7,500.
High Value Oversize ReHolder	£35	A coin in an NGC Oversize Holder (coins over 45 mm) is placed in a new holder. Unlimited value.

OTHER SERVICES	FEE (GBP)	DESCRIPTION
Designation Review	£14 per coin	NGC-certified coins you'd like reviewed for a particular designation, such as "FB," "RB" or "★." There is no Designation Review service for "⊕," which must be submitted for ReGrade. For varieties, use VarietyPlus and separate from Designation Review. Select High Value Designation Review for coins valued over £7,500.
High Value Designation Review	£40 per coin	Select this service for Designation Review for coins valued over £7,500.
Appearance Review	£0 per coin	A service for review of an NGC-certified coin you believe is overgraded.
Return Packaging	£5 per form	Select this service if you would like capsules, Certificates of Authenticity and Mint boxes returned. Does not include shipping expenses, if required.

NGC IMAGING SERVICES	FEE PER COIN (GBP)	DESCRIPTION
Internet Imaging	£4	If chosen, NGC provides digital imaging for coins submitted under any of its grading and service tiers for £4 per coin. Consists of accurate high-resolution images of the obverse and reverse of the coin, shown encapsulated in its NGC holder. Applies to all coins on the form.
NGC Photo Vision	£12	A PDF with high-quality enlarged images of the obverse, reverse and label information. Sent by email.

#### IMPORTANT:

• **Coins that are not encapsulated.** Certain examinations result in a coin that is not encapsulated by NGC. For coins that are not encapsulated because they are deemed by NGC as "NOT GENUINE" or because they have altered mintmarks, altered dates, altered surfaces, surface residue or PVC, the full NGC grading fee applies. For coins that are not encapsulated because they are deemed by NGC as "QUESTIONABLE AUTHENTICITY," or not suitable for certification or have insufficient detail to identify, the NGC grading fee is credited to your account less a £5 service fee. # NCS UK Services & Fees

Effective July 1, 2018

For submissions to NGC International UK Ltd. (NGC UK) only.

US, world and ancient coins must be submitted on separate submission forms.

All fees are in pounds and exclude VAT.

Fees include round trip shipping and insurance between the NGC UK and NCS Headquarters.

A £12 handling fee per submission form applies to all submissions.



NCS is the official conservation service of the ANA and PNG.

NCS CONSERVATION TIERS	FEE PER COIN (GBP)	REQUIREMENTS (Maximum values are per coin)
Standard Conservation	4% Fair Market Value (FMV) (£20 minimum fee)*†	All coins. 4% Fair Market Value (FMV) (£20 minimum fee). NGC grading fees additional. If NCS believes that conservation will not benefit a coin submitted under the Standard Conservation tier, it will be transferred to NGC for grading and <b>only</b> the NGC grading fees will apply.
NCS Gold + NGC Grading	£55	All <b>uncertified</b> gold coins, both vintage and modern, except ancient coins and coins requiring an NGC Oversize Holder (over 45 mm). Fee includes evaluation, conservation and grading/encapsulation by NGC. Maximum value £2,500 per coin. If NCS believes that conservation will not benefit a coin submitted under the NCS Gold + NGC Grading tier, it will be transferred to NGC for grading and the full fee will apply.
NCS Modern + NGC Grading	£30	All <b>uncertified</b> coins 1955 to present, except coins requiring an NGC Oversize Holder (over 45 mm). Fee includes evaluation, conservation and grading/encapsulation by NGC. Maximum value £1,500 per coin. If NCS believes that conservation will not benefit a coin submitted under the NCS Modern + NGC Grading tier, it will be transferred to NGC and the full fee will apply.

\*Declared value MUST represent fair market value and NCS reserves the right to make adjustments for undervalued items.

†NGC Oversize Holder fee of £18 per coin applies to coins over 45 mm in diameter.
